#### **CONCEPT & TERMS**

In accordance with the Agreement established between 2050Today and SIG (Services Industriels de Genève), any institution that is a member of 2050Today and a signatory of the 2050Today Charter may request a Negawatt Support provided by SIG through the Eco21 Program for environmental performance actions.

To benefit from this support, the member is invited to complete the Support Request Form.

SIG is an autonomous public company headquartered in Geneva, whose mission is to supply water, gas, electricity, and thermal energy to Geneva, manage waste, collect and treat wastewater, and provide telecommunications services.

The goal of SIG's Eco21 Program is to contribute to achieving the objectives of the cantonal energy policy and to accelerate the deployment of the environmental transition in Geneva.

Within this context, SIG-Eco21 offers Negawatt Support to 2050Today members to facilitate the implementation of actions aimed at improving their energy and environmental performance, thereby helping them reach the decarbonization objectives they have committed to under the Paris Agreement.

## SUPPORT

The Negawatt Support program offers 2050Today members the opportunity to:

- Develop and monitor their energy efficiency strategies and benefit from financial support from SIG-Eco21, particularly related to electricity savings and CO2 emission reductions falling under Negawatt;
- Develop and monitor their waste reduction strategy, as well as promote the development of a circular economy;





- Include any efficiency action not expressly mentioned in the Negawatt Support Program that aims to improve current and future environmental impact.
- Participation in the Negawatt Support Program involves no costs and no legal obligation.

#### **SIG COMMITMENT**

SIG undertakes to implement Negawatt Support tailored to 2050Today members and to offer financial assistance depending on the actions implemented.

SIG supports actions within the scope of Negawatt Support in the following ways:

- For each kWh of electricity saved, the amount of financial support from SIG-Eco21 depends on the individual energy supply choices of the members. Commitment levels and associated financial support are available on the SIG website.
- For reductions in CO2 emissions resulting from an Environmental Performance Action (APE in french), SIG-Eco21 will propose a contract to purchase the avoided CO2 tons.
- For "Waste & Circular Economy" Support, SIG provides technical assistance, including existing services or those developed by SIG-Eco21.
- For any other efficiency action not expressly mentioned in the Negawatt Program but stemming from a SIG-Eco21 solution that aims to improve the current and future environmental impact of members, SIG will propose an adapted support and incentive scheme.
- The financial support amounts from SIG-Eco21 are published on the SIG website. The applicable amount is the one validated at the time of payment of the financial support by SIG-Eco21.
- SIG commits to informing the relevant Members of any changes regarding the people involved in this Support.







#### **COOPERATION WITH SIG**

- In accordance with the 2050Today Charter, 2050Today or the Member will provide the necessary and useful data within the framework of the Support, such as energy consumption, waste volumes generated, etc.
- Certain support measures or technical solutions may require, with the prior agreement of the Member concerned, the involvement of third parties. The Member will cooperate with them in the framework of the Support and will inform SIG-Eco21 in case of malfunction.
- The Member will inform SIG-Eco21 of any changes regarding the people involved in the Support.

## **DURATION**

The duration of the Support is initially three years. At its end, the Support is tacitly renewed for successive periods of twelve months, unless terminated by the supported Member with three months' notice effective at the end of the month.
